• Note: A handling fee of \$25.00 may be charged for dogs that are very aggressive or hard to handle. **This is a contract between Palouse River Kennels (hereafter “Kennel”), and the pet owner whose signature appears below (hereafter “Owner”).**

1. Owner agrees to pay the current rate for boarding and training in effect on the date the pet is checked into the Kennel.
2. Owner further agrees to pay all veterinary costs for the pet during the time said pet is in the care of the Kennel.
3. Owner further agrees that the pet shall not leave the Kennel until all charges are paid to Kennel by Owner.
4. By signing this contract and leaving pet with Kennel, Owner certifies accuracy of all information about pet on contract.
5. Kennel shall exercise reasonable care for the pet while boarding / training. It is expressly agreed by Owner and Kennel that Kennel’s liability shall in no event exceed the lesser of the current value of a pet of the same species, or the sum of \$200.00 per animal boarded. The owner agrees to be solely responsible for all acts or behavior of said pet while it is in the care of the Kennel.
6. In the event that your pet is able to effectively escape from the Kennel or play yard, Owner agrees not to hold Kennel liable.
7. Owner specifically represents that he/she is the sole Owner of the pet, free and clear of all liens and encumbrances.
8. Failure by Owner to contact Kennel within three (3) working days of estimated date of pick-up shall be grounds to consider the pet abandoned.
9. All charges incurred by Owner shall be payable upon pick-up of pet. The Kennel shall have, and is hereby granted a lien on the pet for any unpaid charges resulting from boarding / training pet at the Kennel. The Owner hereby agrees that in the event the charges are not paid when due, the Kennel may exercise its lien rights upon ten (10) days written notice given by sole discretion of the Kennel, and Owner waives all statutory or legal rights to the contrary.
10. In the event the pet is declared abandoned, Kennel shall have the right to sell or place the pet.
11. If the pet becomes ill or requires professional attention, the Kennel, in its sole discretion, may engage the services of a veterinarian, administer medication, or give requisite attention to the pet, and the expenses shall be paid by Owner.
12. This contract contains the entire agreement between the parties. All terms and conditions of this contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and the Kennel.
13. Any controversy or claim arising from this contract, or breach thereof, or as a result of any alleged negligence by any party to this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association.
14. \_\_\_\_\_ I understand that Palouse River Kennels requires a bordetella vaccination every 6 months and should be administered prior to boarding. I understand the vaccination is approximately 50% effective. I accept all risks that my pet may be exposed to bordetella.

**Entering the Kennel grounds without permission and assistance is criminal trespassing and will be prosecuted as such, as well as a \$1,500.00 trespassing fine enforced. Abandonment of any animal is a criminal act and will be prosecuted.**
